NOTICE OF TITLE IX AND VAWA COMPLIANCE

Title IX of the Education Amendments of 1972 (Title IX) and its regulations prohibit discrimination on the basis of sex in education programs and activities operated by recipients of federal financial assistance. Sexual harassment that creates a hostile environment, including sexual assault and other forms of sexual misconduct, is a form of discrimination prohibited by Title IX. The regulations implementing Title IX require that the University adopt and publish grievance procedures providing a prompt and equitable resolution of complaints that allege any action that would be prohibited by Title IX, including sexual assault, sexual harassment, and other forms of sexual misconduct. Similarly, the Violence Against Women Reauthorization Act of 2013 (VAWA) requires prompt, fair and impartial investigation and resolution of allegations of stalking, dating violence, and domestic violence.

FEDERAL STUDENT FINANCIAL AID PENALTIES FOR DRUG LAW VIOLATIONS

Higher Education Opportunity Act (HEOA) mandates that students who are receiving federal financial aid and who have a conviction of any offense involving the possession or sale of illegal drugs lose federal aid eligibility. MISSING STUDENT PROTOCOL AND EMERGENCY CONTACT

The Higher Education Opportunity Act (HEOA) mandates a protocol applying to on-campus resident students who may be reported as missing for 24 hours or more. The University of North Dakota (UND) will investigate any report of a missing UND student residing on-campus (residence halls, University Place and University Apartments) and take appropriate action to ensure all notifications and actions comply with legal mandates. Investigation of such reports will be initiated immediately by the University of North Dakota Police Department (UPD) and appropriate local law enforcement agency. Procedures are governed by federal and state laws, local ordinance, and University policy, and are implemented by internal standard operating practices.
